This session will white-board how SHOT might decide to respond if a brief or comment is needed to clarify historical issues in American technology and business in a U.S. court of law. Before we identify a relevant case, SHOT might prepare for this possibility, organizationally, to assure the process is well-considered, democratic, and transparent.

The American Historical Association has over the past decade submitted amicus briefs, often in collaboration with its affiliated societies, or publicized amicus briefs submitted by individual members. These were in cases where historical fact needed clarification, or where historical practice was attacked. These cases all dealt with social, cultural, or political history, not yet with the history of American technology.

In no way does this session commit SHOT to anything. This is part discussion, part workshop meant to scope out the potential for action. The word "advance" in the title is intentionally vague, a placeholder as we decide on a more active verb like draft, endorse, or submit. The opportunities for amicus briefs come rarely. More frequently needed is public comment on proposed regulation, and this same process might also work for that. This is a US-specific session, but all members can participate.






